TERMS AND CONDITIONS:-

- (A) The Societies/Contractors should be registered with EPF commissioner & possess I independent EPF A/C Number
- (B) The Society should be registered with Registrar Co-op Societies Punjab
- (C) The L/C Co-op Societies should be enlisted with Punjab PWD (B&R), MES, Irrigation Deptt. or any other Govt. Deptt.
- (D) The societies/contractors should possess:-
 - PAN No. is essential
 - GST No. is essential
 - ESI No. is essential before the 1st Running Bill of the work.
- The contractor/Society shall submit labour license from Pb. Labour Deptt. after the allotment of work.
- The Contractors should have registered with Pb. Govt./Central Govt. Deptt. such as PSPCL/PSTCL, PWD Pb., Pb. IB, MES, CPWD, Railway etc. (essential) for appropriate class/financial limit.
- The bidder should have experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:-
 - three similar completed works costing not less than the amount equal to 40% of the estimated cost i.e 1 lacs
 - Two similar completed works costing not less the amount equal to 50% of the estimated cost i.e 1.25 lacs
 - one similar completed work costing not less than the amount equal to 80% of the estimated cost i.e 2 lacs.

Similar works means "Mechanical works".
- A set of tender documents (non transferable) consisting of specification & general terms & condition can be obtained from the office of undersigned against payment of Rs. 12/- for upto 5000/-, Rs. 59/- up to 1,00,000/-, Rs. 590/- from Rs 1 lakh to 2 lakhs & Rs. 1180/- from 2 lakh to 1crore (non refundable) including GST @ 18% by cash or in shape of demand draft in favour of Resident Engineer/(Op), UBDC PSPCL Malikpur on any working day.
- Every tenderer shall produce along with his tender a solvency certificate from scheduled bank where his firm's a/c is being maintained.

7. Societies & contractors must submit affidavits that they have not been blacklisted by Govt. Agency.
8. Conditional tenders, the tender received telegraphically, through Fax/ Telex and tender, without earnest money shall not be accepted.
9. The competent authority reserve the right to reject any or all the Tenders received without assigning any reasons what so ever.
10. PSPCL Works Regulation-1997 & its Amendment will be applicable, a copy of which can be downloaded from PSPCL website.
11. As per Under Secy./IR, PSPCL, Patiala memo No. 2830/70 IRO 539 dt. 15-07-2016 contractor or sub-contractor must register their labour under the Labour Deptt. as per Regulation 7&12 of buildings and other construction act-1996.
12. Supply, installation, testing and commissioning of motorized rolling shutter of size 4.25 m (W) × 6.40 m (H), including conversion of existing manual rolling shutter into motorized operation complete in all respects. The shutter shall be operated by a **Toshi/Gandhi make heavy-duty industrial motorized drive unit of minimum 1000 kg lifting capacity**, complete with gearbox, braking system, control panel, limit switches and manual override arrangement. The shutter curtain shall consist of **16 gauge GI louvers** of approved quality conforming to relevant IS standards. The spring assembly shall comprise **high tensile strength steel springs** suitable for smooth and balanced operation of the shutter. The **lock plates, side racks, brackets and other structural accessories shall be fabricated from MS (Mild Steel)** sections of adequate size and strength conforming to relevant ISI specifications. the work shall include all labour, welding, cutting, fitting, testing and commissioning required for satisfactory operation of the motorized rolling shutter complete in all respects to the satisfaction of the Engineer-in-Charge.
13. **Earnest Money:** EMD is Rs. 5010 for this tender shall be deposited by cash or in shape of demand draft in favour of Resident Engineer/(Op), UBDC PSPCL Malikpur on any working day.
14. PSPCL is registered centrally in the state under GSTIN 03AAFCP5120Q1ZC.
 - i) GST, as applicable, will be paid as per prevailing provisions of GST Act. & Laws against submission of documentary proof at rate(s) prevailing during the contracted delivery period on the basis of actual. The following certificates shall have to be furnished along with invoice-cum-gate pass duly signed by the authorized agent/signatory.
 - Certified that the transaction on which the GST is claimed has been/shall be included in the return submitted/to be submitted under GST law and the amount claimed from the Punjab State Power Corporation Ltd. has been deposited/shall be deposited with GST Authorities.
 - Certified that the supplies on which GST has been charged have not been exempted under GST Act or rule made there
 - under and that GST charged on these supplies is not more than what is payable under the provisions of relevant act.
 - Certified that we shall indemnify the Punjab State Power Corporation Ltd. in case, it is found at a later stage that wrong or incorrect payment had been received on account of GST; the same will be refunded.
 - Certified that we are registered under the GST Act and our Registration No. is _____
 - Further any loss due to non-availability of ITC or levy of penalty/interest payable by PSPCL on account of non-filing of return or non-compliance or any miss-statement given under the provisions of GST ACT by the contractors shall be recoverable from them.
15. If you fail to execute this work within a stipulated period the penalty @ 0.5% per week will be imposed upon you subject to maximum 10% of the cost of this work order.
16. The payment will be made for the actual work done by RE (OP) UBDC Malikpur directly into contractors bank account through RTGS/NEFT.
