TERMS AND CONDITIONS:-

1. (A) The Societies/Contractors should be registered with EPF commissioner & possess independent EPF A/C Number
- (B) The Society should be registered with Registrar Co-op Societies Punjab
- (C) The L/C Co-op Societies should be enlisted with Punjab PWD (B&R), MES, Irrigation Deptt. or any other Govt. Deptt.
- (D) The societies/contractors should possess:-
 - (i) PAN No. is essential
 - (ii) GST No. is essential
 - (iii) ESI No. is essential before the 1st Running Bill of the work.
2. The contractor/Society shall submit labour license from Pb. Labour Deptt. after the allotment of work.
3. The Contractors should have registered with Pb. Govt./Central Govt. Deptt. such as PSPCL/PSTCL, PWD Pb., Pb. IB, MES, CPWD, Railway etc. (essential) for appropriate class/financial limit.
4. A set of tender documents (non transferable) consisting of specification & general terms & condition can be obtained from the office of undersigned against payment of Rs. 12/- for upto 5000/-, Rs. 59/- up to 1,00,000/-, Rs. 590/- from Rs 1 lakh to 2 lakhs & Rs. 1180/- from 2 lakh to 1 crore (non refundable) including GST @ 18% by cash or in shape of demand draft in favour of Resident Engineer/(Op), UBDC PSPCL Malikpur on any working day.

6. Societies & contractors must submit affidavits that they have not been blacklisted by any Govt. Agency.
7. Conditional tenders, the tender received telegraphically, through Fax/ Telex and tenders without earnest money shall not be accepted.
9. The competent authority reserve the right to reject any or all the Tenders received without assigning any reasons what so ever.
10. PSPCL Works Regulation-1997 & its Amendment will be applicable, a copy of which can be downloaded from PSPCL website.
11. As per Under Secy./IR, PSPCL, Patiala memo No. 2830/70 IRO 539 dt. 15-07-2016 contractor or sub-contractor must register their labour under the Labour Deptt. as per Regulation 7&12 of buildings and other construction act-1996.

12. **Earnest Money:** EMD is Rs 5000 for this tender by cash or in shape of demand draft in favour of Resident Engineer/(Op), UBDC PSPCL Malikpur on any working day.
13. PSPCL is registered centrally in the state under GSTIN 03AAFCP5120Q1ZC.
- i) GST, as applicable, will be paid as per prevailing provisions of GST Act. & Laws against submission of documentary proof at rate(s) prevailing during the contracted delivery period on the basis of actual. The following certificates shall have to be furnished along with invoice-cum-gate pass duly signed by the authorized agent/signatory.
- Certified that the transaction on which the GST is claimed has been/shall be included in the return submitted/to be submitted under GST law and the amount claimed from the Punjab State Power Corporation Ltd. has been deposited/shall be deposited with GST Authorities.
 - Certified that the supplies on which GST has been charged have not been exempted under GST Act or rule made there
 - under and that GST charged on these supplies is not more than what is payable under the provisions of relevant act.
 - Certified that we shall indemnify the Punjab State Power Corporation Ltd. in case, it is found at a later stage that wrong or incorrect payment had been received on account of GST; the same will be refunded.
